



The Visegrad Patent Institute (VPI) is an intergovernmental organization that facilitates the access of applicants from the Central and Eastern European region to the international patent system established by the Patent Cooperation Treaty (PCT) that offers a favourable and efficient route to obtain patent protection abroad.

The VPI acts as International Searching Authority (ISA) and International Preliminary Examining Authority (IPEA) for the nationals and residents of the contracting states: the Czech Republic, Hungary, the Republic of Poland and the Slovak Republic as well as for international applications filed by nationals and residents of Lithuania and Serbia.

INTERNATIONAL SEARCH

Find the most relevant prior art documents regarding the claimed subject matter of your international application.

INTERNATIONAL PRELIMINARY EXAMINATION

Obtain a preliminary and non-binding opinion as to whether your invention appears to be novel, to involve an inventive step and to be industrially applicable in the international phase after the International Search.

INTERNATIONAL-TYPE SEARCH*

Find relevant prior art regarding the subject matter of your application at an early stage of the national patenting process, and even before or without filing an international application.

PCT ISA/IPEA RIGHT NEXT DOOR

File your international application with your respective national patent office as receiving office. The VPI is seated in Budapest with Branch Offices in the V4 countries. You can also choose the International Bureau of WIPO as Receiving Office, if you wish.

USE YOUR NATIONAL LANGUAGE

Save time and money with filing your international application in your respective national language and talk to the patent examiner in a language you both feel comfortable using. Translation to English can follow at a later stage.

ENJOY SIGNIFICANT FEE REFUNDS AND REDUCTIONS

Get 40% of the international search fee refunded if an earlier search was carried out by any of the national IP offices of the V4 countries, Lithuania and Serbia, or 50% of the international search fee refunded if an earlier international-type search was carried out by the VPI for HU, PL or SK national applications. Save another 1300 EUR of the supplementary European search fee, and 220 EUR on the examination fee in the European regional phase.

HIGHLY SKILLED PATENT EXAMINERS

Trust your application to the experience of highly skilled patent examiners in four national patent offices who are experts in all technical fields and participate in continuous learning and development.
